The California Governor's Office of Business and Economic Development (GO-Biz) is supporting up to 10 California small businesses to participate in the U.S. Department of Commerce's Trade Mission to Canada and Mexico and Business Opportunities in the America's Conference September 17-22, 2023.

This is a multi-sector focused trade mission. The combination of the Trade Americas conference and customized business-to-business matchmaking appointments in ONE or TWO cities with pre-screened potential buyers, agents, distributors, or joint venture partners. To qualify for the discount, companies must participate in matchmaking meetings in at least one market.

#### **APPLICATION PROCESS:**

Please note, this is not a public event, the trade mission is reserved for vetted professions only.

- Interested companies must first register with the U.S. Department here at <u>emenuapps.ita.doc.gov/ePublic/TM/3R26</u>
- Once accepted into the program, a CA company will need to submit a STEP Event application via <u>step.business.ca.gov/</u>. (Select "Trade Mission to Canada and Mexico" from the list of activities).
- The California STEP team will review applications and notify eligible applicants if they have been selected.
- Selected companies will need to pay the reduced participation fee directly to the U.S. Department of Commerce.

STEP Eligible California small businesses can receive a \$2100 or \$2850 up front subsidy (firstcome-first-served)
